### New Members Q & A

Starting with this issue of *The Perfins Bulletin*, a **New Members Q&A** column will be featured. When I started collecting perfins, I had many questions about the rating system, value of perfins, where to find perfins, etc. I believe that most new members (and maybe some not-so-new members) have those same questions. Eventually, several of these questions were answered by the various informative articles in *The Perfins Bulletin*. I also found attending the Annual Conventions was very helpful where I could "corner" more experienced perfin collectors.

We hope this column will shortcut some of this time and allow all of our members to gain greater enjoyment from this great hobby. Some of the questions we will discuss in this column will be subjective and controversial (see the first question discussed below). Others will be straightforward. Either way, this is really your column and this is your chance to get your questions on the table. Comments and differing opinions from experienced club members are welcomed and will presented in future issues as appropriate.

Jerry Hejduk (#LM3710) has agreed to be the Associate Editor for this column. Please help Jerry by sending him or the Editor your questions and comments.

### How is the Value of U.S. Perfins Determined?

Perfin patterns are rated on a scarcity scale from A to F. An A rate is given to patterns where there are ten or less copies known to exist. The B+ rate is given to patterns where there are 11-20 copies known. The B rate has 21-40 copies known; C+, 41-80 copies known and C rated perfins are often found in collections of 2400+ different patterns. The D+ rating is considered above average in rarity and D patterns are considered average in rarity, in that they are found in collections of 1200-2400 different patterns. The E rate is considered to be common and the F rate is found in practically all collections.

There is no reference catalog assigning a \$ value to each of the 6400 + U.S. perfin patterns. However, for the practical purpose of trading duplicates with other collectors, an unpublished value scale has developed;  $F=10\phi$ ,  $E=15\phi$ ,  $D=25\phi$ ,  $D+=50\phi$ , C=\$2, C+=\$4, B=\$8, B+=\$16 and A=\$30. Based on this generally accepted value scale, collectors are comfortable trading two C's for a C+, two C+'s for a B, two Bs for a B+ or two B+s for an A. These values are not cast in stone; nor would <u>all</u> collectors completely agree to these relative values, but over the last decade most reasonable collectors have generally embraced such a scale, because if they are selling their duplicates, rather than trading them, the above values appear to be "in play."

The above discussion does not apply to Schermack Coil Punches listed in the Catalog of U. S. Perfins. These stamps have a higher rarity factor for perfin collectors as well as a considerable interest from other collectors of U.S. postage stamps. Many regular stamp dealers offer them at unusually high prices. These private coils have only four different ratings, and generally speaking, their value is about double that of similarly rated other U. S. postage stamp perfin patterns; B=\$15, B+=\$30, A=\$60 and A+=\$100-\$120. You will note that such a value scale also accommodates trading duplicates; two Bs for one B+, two B+s for an A etc.

One would be remiss if a mention of "prices realized at auction" did not get included in a discussion of values of perfin patterns. The reader has probably noted unusually high prices are frequently realized at auction. Two or more bidders with deep pockets in competition, produce a different result than two collectors, trying to negotiate a reasonable exchange. Therefore, new members are cautioned to not consider auction prices realized as the standard accepted value of perfin prices, but rather, should refer to what collectors are using as fair value exchange rates.

The one caveat is that I will forward any article with an "identifying cover" or other information that might impact the catalog listing of that perfin to the respective catalog editor for verification, approval, and/or comment. This will prevent publishing information that has already been covered in the catalog or one of its C&A's.

For those that wish to send your article electronically, my default word processing software is MS Word 2007. However, I also have the Open Office suite on my machine. So, I should be able to read almost any electronic file you send. For scans, any form of electronic image is OK, however, 300 dpi or higher will reproduce better in print.

As for deadlines, we plan to continue to publish the *Bulletin* on a by-monthly schedule. That means an issue on the odd numbered months (January, March, May, etc.) I would like to have your copy by the 1st of the month prior to publication (February. April, June, etc.) That will give me sufficient time for formatting, layout, and sending it to the printer so it will reach you early in the month of issue. I will make every attempt to get any late arriving articles in the next *Bulletin*, but sometimes they will be a good start for the next one.



### The Perfins of Venezuela



Having volunteered to work with John Randall in updating Bob Schwerdt's World Perfins Catalog, I was assigned the task of being the Editor for the America's portion of the World Perfin Catalogue some years ago. At that time I did a lot of research on the subject and researched and referenced several large world collections. Being only one among many manuscripts requiring cataloging decisions, review and revision, the manuscript has languished (most recently over listing issues). So, for the time being, I am going to provide drafts of the information I have learned in a few articles.

Venezuela was not a prolific user of perfins. To date, I have not seen a commercial (or other) perfin used in regular postage stamps, other than the Official 'GN' perfins. Following is a listing of the patterns I have seen (minus P8, which has been described as "PA??? with 11 mm tall fine letters, possibly PAGADO) in the stamps of Venezuela using the designations that were used by Bob Schwerdt in the current version of the Americas catalog. These may or may not be the designations used in the upcoming catalog when it goes to press. [Editor's note: Pattern P8 has been reported to the author, but not seen by him. Thus, no illustration can be provided below.]










P11-- ax

Some general notes about the patterns seen:

- B1 is seen on the Instruccion revenues of 1911-1914.
- B2 is only seen on the Instruccion revenues of 1914.
- B3 is on the Instruccion revenue of 1914.
- C1 is only seen on the Instruccion revenues of 1910-1914
- C2 is seen on a 1914 Instruccion revenue, centered on the stamp.
- The balance of 'C2' perfins are all on the edge of regular postage stamps of the 1915-1921 era. It appears that they may have been put on the edge of the stamps for a period of time to not show the '1914'. And possibly, for a very short time, the 1914 was removed and they were used on revenue stamps.
- C3 was used on Venezuelan stamps from 1915 until 1943, when they apparently stopped the requirement of perfinning official usage stamps. Every stamp issued during this period has been seen with the G.N perfin, including airmail, semipostal, air semipostal and one issue not recognized by Scott, a 5c dark green semi-postal (postal-tax?) stamp. The perfin has been counterfeited. (See illustration) Listings of the stamps perfinned are available in the old Yvert & Tellier

catalogues, the "Michel" Sud Amerika catalogue and the 1991 Venezuela 'Catalogo Especializado de Estampilas'. All of these indicate values for the various issues; the values range from 0.20¢ for the commoner items to \$180.00 for the scarcest item, and are priced used and unused. Scott, for some reason, has chosen not to list the Official issues of the world when they are only identifiable by a perfin punch.

• PI-PI3 are all seen on the 1911-1915 Instruccion series of revenues.

Note: The 'P' designation is being used by the author to indicate punches and cancelling perfins that were only used on Revenue issue stamps. The 'B' designation is separated and used until it can be determined whether the stamps were perfinned prior to being affixed to documents. This is one of the sticking points holding up the printing of the America's catalog. There are a number of perfins from Chile, Uruguay & Argentina that were punched through the stamps and the documents as a form of cancellation. How to designate these perfins is a problem, as they are often regular commercial 5 head perforators, and seem to mostly have been used only on revenues. I am not sure how these will finally be cataloged, so this 'P##' scheme is tentative at this time.

# My Favorite Foreign Perfin Page(S)

Recently Steve Endicott (#2284) requested that members report their favorite U.S. perfin(s) for whatever reason: scarcity, attractiveness, etc. From the information submitted, Steve brought to the July/August Precancel/Perfins convention at St. Louis a fine, thirty-page exhibit of member favorites with pertinent write-up and explanation - by Steve. Ownership of the various items was kept anonymous. (See pages 10 & 11 for the second installment of Steve's exhibit.)

Since our *Bulletin* Editor is on a perpetual quest for articles, I thought we might try a similar "favorite" idea with foreign perfins and give him a break by requiring the collector to write the corresponding explanation if one is necessary.

The page or pages really don't have to be of exhibition quality. They could be stock pages of one's favorite items. The page may contain perfins of more than a single country - a thematic approach? Who knows what clever arrangements we foreign perfin collectors can devise! The write-up could be a one liner or extended. I am certain that the foreign perfin collectors care as deeply about some of their material as do perfin collectors of U.S. material.

The "why" is important: why is this one of your favorites?

So, how about it? What do you say? Shall we give it a try?

I'll start the process with an exhibition page of Austrian Levant (Austrian Offices in Turkey) perfins. As you can tell, this page needs remounting and may even become two pages. I certainly would appreciate knowing if there are additional Austrian Levant perfins that are not shown here.

[Editor's Note: For those who are not familiar with the term 'Levant' (myself included), my research reveals it is the name applied to the geographical region of the eastern shores of the Mediterranean Sea from roughly the Isthmus of Suez to the Tarus Mountains. The northern part of this area is the south-east region of Turkey that was included in the Austro-Hungarian Empire until the end of World War I.1

You will note that my "T." perfin is not in alphabetical order. It was acquired long after I had thought my page was complete. Since then, two more Austrian Levant perfins have been reported: "C.A.S." and then "F.C." If I should ever find these two, then my page would be complete! Or would it? So, in truth, this is one of my favorite pages because I thought that it was a complete collection of Austrian Levant perfins. The page is still a favorite because now it presents a challenge to regain completeness by seeking the known missing items.

I know that some collectors may have a difficult time selecting one favorite page - no problem - submit several pages. Your Editor will be happy, and other members might be inspired to broaden their perfin interests.






Perfins of Austrian Offices

### New Perfin from Florida

For reasons unknown, I noticed something different in the baseball commemorative stamp used to mail The Florida Precancel Club's notice of their annual winter meet. What caught my eye was the perfin 'FP' neatly placed in the stamp. The cover is shown below with a Photoshop mockup of the pattern (to avoid removal of the stamp from the cover.)



The pattern measures  $8.5 \times 13$  mm (center of top hole to center of bottom hole) with 0.75 mm holes. Translating this to English measure this is  $0.5118 \times 0.3346$  inch with 0.295 inch holes. I would judge this to be an 'Illegal" pattern, but will leave that decision to the U.S. Catalog Editor to whom I forwarded a copy of this information.

I have written Jerry Hedjuk (LM#3710 and editor of the Florida Rambler), requesting more information and perfins for the Catalog Editor. As an aside, I can heartily recommend that you attend the Florida Precancel Club's Winter Meet, February 11-14, 2009 at the La Quinta Inn, Orlando/Winter Park, Florida.

Not only is the weather and the company great, but there are ample opportunities to meet fellow perfin collectors and to enhance your perfin and precancel collections. (See page 17 for more information on this Meet.)

[Ed. Note: Those who read Bob Szymanski's note in the September/October 2008 Bulletin (p. 163-165) will recognize this as the new pattern used by Jerry Hejduk for the first time on July 29, 2008 (during the Clubs' annual convention.) Only Jerry knows whether the 'FP' stands for Florida Precancel, Florida Perfin, maybe both, or something else altogether. More shortly I hope.]

# My Favorite Perfins - Part II

I began a discussion of favorite and most unusual U.S. perfins in the September/October 2008 Bulletin, with a promise of more to come. In this issue, I present part II of the display presented at the recent convention in St. Louis. The subject for this installment is perfins in the Columbian Exposition issue of 1893.

We all know that the Columbian Exposition stamps were first issued in 1893, fifteen years prior to the authorization of perfin usage in the United States. The Columbian stamps were issued in the large rectangular format that we often associate with modern-era commemorative issues. This format was disliked by the public at that time; thus, these stamps were available in post offices for many years.

Shown on the next page (page 11) is a cover to a foreign destination using a perfin in a stamp from the

Columbian Exposition. The cover was mailed from San Francisco, CA to Guatemala and is the EKU for a US perfin to Guatemala. This cover is presented courtesy of Bob Szymanski. Please let me know if you own covers with perfins to these countries with dates earlier than 1915

Finally, we have found two Columbian stamps with perfin pattern H54 used by the G.F. Harvey Company. We have the six cent and 50 cent Columbian denominations of this perfin. Do you have other Columbian denominations of this perfin?

I would enjoy hearing from anyone regarding perfins that they own on the Columbian Exposition issue. All comments are most welcome. See page 2 for my contact information.



### **Fascinating and Unusual United States Perfins**

#### Perfins on Covers with the Columbian Issue

The use of perfins in the United States was first authorized on April 9, 1908. Most early U.S. perfin usage is seen on the 1902-03 definitive stamps issue. The Columbian Exposition issue of 1893 preceded perfin usage in the United States by 15 years. However, these large, rectangular stamps were widely disliked by the public and stocks of these stamps languished in post offices for many years. Oh, how I wish I could find some in post offices today! Some of the stamps were later purchased and then perfin patterns were applied. A spectacular example of a perfin on a Columbian Exposition stamp is shown here.


# First Day of Issue Perfin

# Prescription for Fun

Bob Schwerdt (#505-L)

### The Prescription

- 1. Select one populated island
- 2. Examine atlas or large map of that island
- 3. Make a list of towns located on that island
- 4. Accumulate a large amount of large-size, light-colored stamps with perfins from that island
  - 5. Compare postmarks on perfin issues with town list
  - 6. Compile want list of needed postmarks missing from perfin issues
    - 7. Locate collector with similar interest and same island
      - 8. Correspond and swap
      - 9. Have fun (steps 1 through 8)!
- #1. I chose Tasmania as the island for my fun. Approximately the size of Sri Lanka, Tasmania is about 2000 square miles larger than West Virginia and about 2000 square miles smaller than Maine. Originally called Van Diemen's Land by Abel Tasman, its discoverer, the island was eventually named Tasmania, and its stamps were so inscribed in 1870. By 1990 the island had about one-half million inhabitants and sufficient towns scattered about to make this island's perfins fun to study.
- #2 & #3. The number of towns gleaned from a National Geographic map of 1948 and from the 1992 Readers Digest Atlas totals some 70+ (some were islands). Naturally, not all towns are included in small scale maps, and, certainly, through the years, some towns can lose their identities by consolidation, by abandonment, or by a change of name. Seventy towns is just about the right number for my fun.
- #4. Of course, as any perspicacious reader knows, I already had a large accumulation of Tasmanian perfins before I chose the island for this project. Since most of my material consisted of "T"

- official perfins in large 1d (value 1 pence) carmine stamps, I had little difficulty spotting town postmarks with circular date cancels. Variations in the "T" perfins are numerous because of the two-step punching: once horizontal and once vertical. But the perfins are another story: for this study they are incidental to the postmarks it's just that I had a slew of issues with the "T" perfin to play with.
- #5. After examining my perfin accumulation (I am still having fun with the identifications), I can account for 28 town cancels of those towns on the atlas and map lists, plus a few towns that were not shown on the maps. Some partial and blurred postmarks were a trifle troublesome, but if I should acquire a correspondent (#7, #8) I'll resolve their identities.
- #6. I have not yet completed a want list. Perhaps a correspondent will pressure me to do this?

Some of the postmarks are illustrated here. The first eight show corresponding town names of those also found on the maps:

There is a Sandy Cape in Tasmania so there might also be a Sandy Bay? The second item suggests a missing "M" for Montville, but the absent letter(s) could be anything.

- #9. I have already had much fun and will surely have more as the study progresses and more "T" perfins arrive with legible postmarks.
- Footnote #1. Webster's New Geographical Dictionary can be helpful in the fun process and also Scott's Catalog if you wish to identify the perfin stamp issues via watermarks and perforations.
- Footnote #2. Additional fun can be achieved by investigating which government agencies or offices from so many towns were required to use the official "T" perfin.

Footnote #3. Now if I could find a large batch of perfins from any of these other islands: Newfoundland, Crete, Malta, or Cyprus with legible town postmarks, I could start to have fun all over again! There just may not be a sufficient number of towns on these small islands to provide the necessary fun for me, so I recommend Tasmania. And for you fun-loving U.S. collectors... consider Hawaii, or Puerto Rico, or...

### PERFINS CLUB STAMP SALES CIRCUIT 101

Bob Combs (LM#24) Perfins Club Stamp Circuit Sales Manager

Hello Perfins Club Members! This mini-article should act as a Sales Circuit Guide and primer for those of you not aware there is a sales circuit associated with the club.

The stamp sales department has an accumulation of nearly 40,000 + stamps on hand for members to look through. The percentage of US versus the World is about 40 (US) to 60 (World). Within the US, we have nearly every type, definitive, commemorative, revenue, Airmail, prepers, you name it. Values covers the range from A's (a very few) to E's & F's (lots and lots). Foreign has many countries to choose from with a fairly good spattering from around the globe. Some are in abundance, some aren't.

BUYERS: Are you thinking of joining the group? Do you need something to fill a hole in your collection? If so, email or write me and I will get a few forms out your way that explains what you need to know, such as:

- 1. You can expect a circuit about every other month.
- 2. The club fees charged are nominal (1% of total circuit value). However, you are responsible for Postage and insurance in both directions.
- 3. Your interests can be either US or Foreign, or a mixture of both.
- 4. Circuits contain a number of packages, each containing a number of perfins. Lower value items are in packages of up to 100, more expensive types are in booklets of up to 100 items.
- 5. I cannot, due to the number of items on hand, do specific stamp, town, pattern, series or whatever want lists. Looking through the packages is most of the fun anyway.
- 6. One can keep the items for several weeks to look through, and if you need longer, let me know so I don't send the Federallies out looking for you.
- 7. Pricing varies from \$0.05 to \$15.00 each.

**SELLERS:** Have spare items sitting around? Why not sell them through the sales circuits and help out a few members to boot! If interested, contact me and more forms (don't you just love them?) will be on their way to you so that you can become an active member of the sales team.

- 1. Submissions have no time limit. Sales items are returned either when they sell out, or seller requests them back.
- 2. You, the seller, determine the pricing of your items. TIP: Lower priced items sell faster than higher priced items (go figure).
- 3. The club charges a 15% fee on all items sold.
- 4. Group all like items in the same package, F's & E's can be grouped, D's, C's, B's & A's should be separated, unless they are to be contained in sales booklets, available from the Circuit Sales Department. \$0.50 each or 12 for \$5.00. Group foreign items by country, again, unless mounted in sales booklets, which should be grouped at least by continent.
- 5. I can supply you with a rough guide for pricing if you need one.
- 6. Payment is usually made 2 times per year, unless low sales deem it otherwise. You should however, receive a statement at least 2 times per year showing your account activity.
- 7. Circuit numbers are assigned by the circuit sales department.

This has been a short synopsis of the Perfins Club Stamp Sales Circuit operation. Now, for the sales pitch! We are in need of just about anything. Better US or Foreign ALWAYS needed. Please contact me if you have any items you would like to sell!

I hope this has been helpful, and that a few of you might decide to give the circuits a try. I look forward to helping each and every one of you finds the items you need for your collections. My contact information is on page 2 of this *Bulletin*.


# A Very Interesting Perfin at Auction

Chris Reuger (#1834) spotted a very interesting and possibly unique perfin (shown at right) in the Matthew Bennett International Auction #330 that closed December 4, 2008.

If you will look closely at the upper two stamps in the center row, you will see that these are the 5-cent rose error. My references indicate that about 75,000 of this SC#505 (perf. 11) were issued and survived. {The same error was also found on the SC#467 (perf. 10) and SC#485 (imperforate), with even a lower number of each surviving.}

The perfin is pattern M205, with a D+ rating. The primary identification is Moline Plow Company, Moline, IL with several additional identifications in the supplemental pages.

Since this one is unused, I wonder if there are used perfin copies out there? Check your stock and duplicates. What a find that would be!! What a story that would make!!
