New Members Q & A

When Asking a Question About Perfins, I Am Often Told To Be Sure To Check the A & C Pages. What Are They, And Why Are They Important?

Over the years, the Perfins Club has published four issues of the *Catalog of United States Perfins*; in 1958, 1966, 1979 and 1998. The issuance in 1998, like its predecessor in 1979, was designed to be both a catalog and an album. New members are encouraged to obtain a copy of the latest (1998) edition to aid in the identification and collection of U.S. perfins, as it is the most comprehensive reference book on the subject.

In 2002, the Perfins Club published Additions and Corrections #1 as an addendum to the 1998 Catalog. It is 22 pages in length addressing:

- A. Corrections of the printed material in the Catalog;
- B. Changed pattern ratings;
- C. Additional information and new identifications;
- D. Extended periods of usage;
- E. New patterns.

It is clear from viewing this publication that the U. S. perfin body of knowledge does not become stagnant even when a comprehensive catalog is published. The 20+ pages in this document are testimony to the amount of new and updated information that presents itself in a period of four years.

In 2006, the Perfins Club published Additions and Corrections #2 (to the 1998 Catalog) following a format similar to as that which was presented in A & C #1. The later publication has a comparable amount of valuable additional and new information for the collectors of U. S. perfins.

Probably the most readily usable information for new collectors is the Corrected Ratings; reflecting the change in the value (rarity) of the individual perfin patterns. There were forty-three (43) such changes in A & C #1 and twenty-eight (28) in A & C #2. If you are buying or trading U. S. perfins, it is important to know the rarity rating of the perfin pattern under discussion.

Many collectors transfer this updated pattern rating information to the Album Pages of the 1998 Catalog; below the picture of the pattern. They strike a penciled line through the old rating and, to the left of the old rating, they "pencil in" the new rating. Then just to the right of the old rating (outside the box), they pencil in either '02 or '06 reflecting the year of publication of the A & C pages in which they found the correction. It is important to remember that we are referring to a 1998 Catalog, because that is the publication for which these Additions and Corrections are made.

Copies of A & C #1 and A & C #2 may be obtained from the Perfins Club Publication Sales Manger, David Lightle. The Perfin Club member cost for A&C #1 is \$5 and A&C #2 is \$6.50, postage paid. Such an investment will show you firsthand how valuable update information can be. See page 22 for David's contact information. Greek Auction Catalog

I recently received auction catalog No. 61 from Alexandre A. Galinos, P.O. Box 3138, GR-102 10 Athens GREECE (kolecti@otenet.gr) for the "Claude" collection of Greek Perfins. I thought this might be of interest to collectors of foreign perfins. The catalog is well illustrated and the web site (www.collectio.gr) is fairly easy to navigate. The catalog has a section in English and Greek on perfins

Treasurer's Report

Although the U.S. and the global economies had a difficult year, I am pleased to report that the financial situation for The Perfins Club is quite strong, perhaps the best I have seen as your Treasurer for the last 7 years.

The total financial assets for the Club are \$78,400, up 3% from December 2007. The major Club sales, auctions, and circuits all reported profits for the year, and donations were up significantly. This all comes from YOUR active participation in the Club – thank you. Expenses are under excellent control. Our annual dues have remained constant for 14 years! Our only area of concern is the recent, gradual decline in membership.

While having \$78,400 in financial assets looks like we are quite rich, it is important to note there are four escrow categories in that total: life memberships; the escrow for member's personal credit accounts; our self-insurance transit fund; and donations reserved for special projects. After subtracting for these special escrows, the Club has a remaining operational balance of \$11,400, which would cover about one year's expenses.

We all need to encourage membership growth. Enthusiastically talk up the fun of collecting perfins to your fellow philatelists.

Prize Winning Perfins Exhibit

Vladimir Munzberger (#3490)

[Editor's Note: Perfins Club member, Vladimir Munzberger (#3490) recently exhibited a prize winning One Frame Exhibit (16 pages) at the World Stamp Exhibition PRAGA 2008. His one frame exhibit "Perfins of Austrian Levant" received 85 points and a Vermeil medal. The following is an example of his exhibit which we believe contributes an interesting article for our readers.]

PRAGA 2008 was held September 12 – 14, 2008 on the Praga Fair Grounds. Over 45,000 visitors attended. It was a major world exhibition under the full patronage of the FIP, but it was specialized into four exhibition classes: Traditional, Postal History, Literature, and One Frame Exhibits. More information about the exhibition is available at the exhibition's web site http://www.praga2008.cz.

At the exhibition, four perfin exhibits were presented. These were the one discussed in this article; another One Frame Exhibit, "Perfins of the Bank of Greece", by Vladislav Beneš from the Czech Republic; a very nice 5-frame exhibit titled "Perfins of the Kingdom of Bavaria" by German collector Reiner von Scharpen; and another 5-frame exhibit, "Perfins used in Czech and Slovak Territory", by Julius Pisa from Slovakia.

I believe that perfins are not only holes thru the stamps, but they are an integral part of postal history and this is the way they should be presented to public. That means that perfins have to be demonstrated in all possible situations in which they had been really used (of course, it is not simple). My exhibit is based on the following general ideas:

- Selection of the territory (in this case Austrian Levant). This also means one must have a certain minimal knowledge about this territory and historical background of its postal services.
- 2. Showing the wide range of perfins from the selected territory as much as possible and preferably better perfins. (From my experience it is very difficult for one collector to put together all of the perfins from any selected territory.)
- 3. Showing the perfins on various stamps (preferably on the better ones.)

- 4. Presenting a detailed study of the perfins, if possible, (in this exhibit very limited) and any new findings in this field.
- 5. Showing the perfins used on various documents, especially with identified users of the perfins. For example, various cards, letters, stationary sent to various destinations (very difficult from Levant), or other postal documents (forms, etc.). It is also important to explain the starting and ending destinations, the correct postage fee, and some other specifics of the documents.
- 6. Reasonable description of the material (not too much, but all of the important things).
- 7. And, of course, one must also have in mind the FIP criteria for evaluation that will be used by the exhibition jury.

The above is one of the many possible ways that one can use to be relatively successful in exhibiting perfins. The degree that I succeeded in fulfilling these ideas and further improvements that could be made in my exhibit is another story and I will let our readers judge it.

The title page, two highlight pages of my exhibit, and two pages that explain how to differentiate between the two EOB perfins and between the two WBV perfins (which I do not believe has been published before my exhibit) are shown on the following pages.

Perfins of Austrian Levant

Levant is a common name for eastern Mediterranean and for the seaside area of original Ottoman Empire infringing South-eastern Europe, the Middle East and northern part of Africa. Aside from the own postal services also postal administrations of many other European countries operated there till the beginning of the WWI and they also issued special stamps for this territory. Among others it was also Austrian postal administration. On this territory Austrian stamp issues for Levant (currency Para, Piaster) and also specific issues for Crete (currency Centimes, Franc) were valid simultaneously.

Perfins originated in 1868 in England and gradually expanded into other countries of the world. In Austrian Monarchy the permission to use perfins was issued on 4 April 1877. On the Levant territory perfins were used by great international companies and banks, many of them originated from European countries. Therefore their same perfins can be found on stamps of more postal administrations (Ottoman, Austrian, German, Great Britain, French, Italian, Russian etc.). Existing perfins on stamps from this territory we can generally consider as less common up to very rare and on covers or cards as rare up to extremely rare. Overwhelming number of perfins on Austrian stamps can be found on the stamp issues for Levant, perfins on Austrian Crete stamp issues are purely outstanding.

This exhibit deals with perfins of Austrian Levant only and is organised by existing perfins carrying an effort to optimise the space on sheets. The overview and placing of perfins is obvious from the attached table. Also the scarcity factors of perfins based on own experience and research, are published there in this table for the first time.

Aside from the stamps with perfins also few unique covers and cards are displayed in the exhibit: perfinned stationery card G.S. (in literature the only one existing item is mentioned), this one even on the Crete stationery issue (page #8), probably the only one known cover with perfin H.C., but without identified user (page #9), outstanding cover "sample without value" with perfin K.B. (page #11), heavy registered letter with perfin P.M. (page #12) etc.

Page #16 displays very interesting usage of perfins on ordinary Austrian stamps of shipping company Lloyd, which served transport connections with the territory of Levant. Their home port was Trieste.

The own research is presented by the scarcity factors as well as better specifying the period of usage of about half of perfins. Also the pictures how to distinguish very similar perfins EOB (1) a (2), WBV (1) a (2) are published for the first time. New findings of 3 perfins on Crete stamp issues are also interesting.







Wrong Perfin Pattern

Brad Baker (LM#3766)

This is a plain-looking cover that hints at an untold story. The 3-cent Washington has perfin pattern V1. The user of this perfin pattern was Vitaphone and others associated with Warner Bros. Flip this cover over, and you will find printed in the middle of the back flap a return address for Ralph Kirbery of the National Broadcasting Company in New York City.

It is not too far-fetched to think these two companies had business dealings together. Vitaphone was in the entertainment business with the National Broadcasting Company. Was a stamp from



Vitaphone given, loaned, or sold to an associate from NBC? Are there other plausible explainations?

What also makes this cover an oddity is that at the time this cover was posted in 1933, NBC was using their own perfin pattern, N30. That makes this cover an example of a perfin user using the perfin pattern of another perfin user.

Do you have a similar example of this oddity in your collection? If so, please share with others in *The Perfins Bulletin*.




One More Non-Postage, Non-Revenue Perfin

Jack Brandt's (LM#14) article in the November/December 2008 issue of *The Perfins Bulletin* (62:176) prompted my memory of an old perfinned label that I had acquired years ago. After a fruitful search, I found the item illustrated below. It is a dated item for flexible cord (isn't all cord flexible?) and shows the initials of the company and inspection date. Perhaps some collector can furnish the name of the cord company? Certainly, the initials would be best suited for a jelly glass company!



In Section O of the new U. S. Revs-Perfins catalog there are illustrations for some Underwriters Laboratories inspection labels for wires, but none for cords. Perhaps this illustration could be added in Section O of the catalog? [Ed. note: This information and illustration was forwarded to Art Mongan, U.S. Revenue Catalog Chairman. Art indicated he will include this in the next revision of the Catalog.]



100 Years Later Perfins in the Abraham Lincoln 1909 Issue

Christian C. Rueger (#1834)

Lincoln was born on February 12, 1809. "100 years later" the first Lincoln commemorative (Scott #367) was produced by the BEP. It was issued by the U.S. Post Office Department on February 12, 1909, for Lincoln's 100th birthday. The 2-cent value satisfied the then current U.S. single ounce, first-class domestic letter rate and the red color met UPU agreements for the same service.

Today - "100 years later" - on Lincoln's 200th birthday, as promised I am updating my previous Bulletin article¹, with more information. includes additional covers shown on the following pages along with 142 new patterns as part of Table 1.

My gift to Old Abe on his 200th birthday is a masterlist of #367 with 403 different perfin patterns. This was developed with the help of Brad Baker (LM#3766), John Brandt (LM#14), Steve Endicott (#2284), Mike Falls (LM#131), Bob Schwerdt (#505 -L), James Sneed (LM#128), Bob Szymanski (LM#145), and Steven Stratford's web site². Thank you all very much for your help.

I am aware of about 50 covers with a perfinned #367 Most of these covers are very nice stamp. Advertising Covers. All postmarks are from 1909. The earliest known use (EKU) is from St. Louis, MO dated February 26, 1909 with pattern S138, Simmons Hardware Co¹. The latest is from Chicago, IL dated October 12, 1909 with pattern 141, International Harvester Co. It seems that all of the #367 perfins were used in a 9 month period. Was it the nice, handsome commemorative in the size of a regular issue that made this stamp so popular?

The stamp also was issued on the same day in imperforate form (Scott #368). Most of these stamps were used as coil stamps by private perforators in vending and affixing machines. The best-of-the-best is Bob Szymanski's find of a vertical pair with jumbo margins. The pattern is I17 by International Banking Co., New York, NY.

On March 18, 1909, the OFFICE OF THIRD ASS'T P. M. GEN'L, WASHINGTON, D. C., notified the Postmasters in a notice titled "Unperforated Postage Stamps" "That The Lincoln memorial stamps will no longer be available after the Department's present supply is exhausted"³. That was only about 5-weeks after the issue of the imperforate stamp.







My Favorite Perfins - Part III

Steve Endicott (#2284)

I began a discussion of my favorite and most unusual U.S. perfins in the September/October 2008 *Bulletin* (62:158-160), with a promise of more to come. In this issue, I present the part of the display presented at the St. Louis convention related to 19th century stamps.

Perfins were first authorized for use in the United States on April 9, 1908. Very few examples are seen on stamps issued prior to 1908. They may have been previously issued stamps still in post office stock, such as the Columbian issues which were the subject of a previous article, or they may have been from another source such as a perforator used in another country.

Shown here are four examples of perfins on 19th century stamps. Subsequent to completion of the display, the last example has been identified in the US A&C #2 set as the new pattern N48i, used by North China Herald in China.

I would enjoy hearing from anyone regarding perfins that they own on these 19th century issues. All comments are most welcome. Finally, I am hoping that another member assembles exhibit material for the Pittsburgh convention this summer. My contact information is on page 22 of this *Bulletin*.

Odd Perfin Use

Talk about esoteric perfin uses, here is an illustration of a Certificate of Mailing Card that was used by deceased member Jacob Kisner.

This is the first one that I have ever seen. You might note that although Jacob used his personal perfin "KIS/NER" (K37.5P) on the 2 cent American series stamp, he managed to find a mint 25 cent 1954 definitive with a "BT/Pa" (B238.5) stamp to use as well. Two additional non-perfinned stamps make up the then current 40 cent rate.

Also, I found it interesting that you can figure out the cancellation date of Oct 19, 1984 but only after checking all 5 circular cancels. Oh, yes, the same service today is \$1.10!





A Perfin from Armenia

William Lesh (#3718)

In the recent private Perfin Auction #21 conducted by Bob Szymanski, a perfinned Armenian stamp appeared as lot #216. Pictured is Armenia old Scott #273, one of a set of 10 that was printed by the Chassepot Printing Works in Paris. This set was ordered by the First Dashnak (Nationalist) Government of Armenia early in 1920. The first printing of this issue was delivered to Yerevan (Erivan) in November 1920, but not in time to be issued before the resignation of the government on December 2, 1920. The first printing that was delivered was small. The second, larger printing was refused due to lack of foreign currency to pay for it.


The stamp in question is a 25ruble value, the inland letter rate in November 1920. It reads ARMENIA at the bottom and Armenian Republic (in Armenian) at the top. It also bears a hammer and sickle over Mount Ararat, which was the coat of arms of the Armenian SSR, formed on November 29, 1920. This first Armenian SSR existed until February 18, 1921, when it was ousted by the Second Dashnak regime. This second Dashnak regime only lasted a few days since the Armenian SSR returned on April 2, 1921. This Armenian SSR then became part of the Transcaucasian SFSR on March 12, 1922 and was subsequently incorporated into the USSR on December 30, 1922.



It is my presumption that the handstamped Chassepot issue came into use during the first Armenian SSR, where it was used as a fiscal. The Second Dashnak government did not make use of them as postage (no longer available?), but continued overprinting Czarist stamps.

The perfin appears to be a common fiscal type use in the Czarist regime. It is a cross pattern, possibly inspired by the Czarist naval ensign. It reads in Russian letters: "Ye" (revan) "K" (ontara=office) and "P" (...). I do not have a clue what the "P" may represent. A 5ruble (#270) fiscal is known, but it has no perfin. It is thought that some perfins in Russia were used as cancellations. Could this be one?

[Perfin Club member Dick Scheper (#3311) offers the following information. The perfin E.K.P. (Э.К.П.) was used by the Chamber of Finance in the Armenian capital of Yerevan. The characters stand for: Erivanskaya Kazennaya Palata. Besides the usage of this perfin in Russian revenue stamps, it is also used from 1919 onward in stamps of the then independent republic of Armenia.]



Auction Watch

Rudy Roy (#1124) recently spotted the Iceland revenue perfin shown here on eBay. There were 13 bids and the winning bid was \$133.50. Bob Schwerdt (#505-L) reminded the Editor that this perfin was discussed in March 2003 issue of The Parfins Bull.



in March 2003 issue of *The Perfins Bulletin* (57:43). From that article, this stylized S.A.I. design was used by the Shell Oil Company in Iceland. Such perfins are very rare and this may the only Iceland pattern reported.

Stephen Tauber (#2949) reports that, as of February 14, 2009, **StampWants** lists 1,156 lots with "perfin" in the title or description. There appears to be an excellent mixture of U.S. and foreign perfins in these auctions. Starting bids are as low as 35 cents and range to several hundred dollars.

Stephen also noticed that **Ocean Park Stamp Auctions** had at least a dozen Canada perfin lots listed as of February 22, 2009.

Introduction to the chapters in the handbook

In General notes on perfins of Turkey and the Levant a short explanation is given about the reason for using perfins by commercial firms and their branches on Ottoman territory.

Some large firms had branches in Constantinople as well as in Smyrna. While both branches used the same perforated initials, they have used a different perforator and their perfins can be recognized by small differences in the perfin pattern. The differences to look for, are explained in the chapter *Identical or different patterns*.

Perfins of the Ottoman empire, Turkey, Crete and the Foreign Post Offices in the Levant Levant by Dick Scheper dick. scheper@planet.nl

In Short history of the Levant post offices some background information is given about the postal history of the foreign post offices of seven European countries. Also 19 perfin covers (in colour) are shown to illustrate the use of perfins in stamps of each foreign post office.

An important part of this handbook is formed by the chapter Perfins of the Levant post offices. In alphabetical order and separated for each foreign post office, all known perfins are shown, not only by their perfin patterns but also by showing 376 full colour illustrations of perfined stamps from all stamp issues which are known with those perfins. The perfin patterns are presented in original size as a result of immediate scanning of the backside of the stamps.

Very few Levant perfins of commercial firms are known to be used in *Levant postal stationary* or in *revenue stamps of the Ottoman empire*. Both category perfins are shown in separate chapters.

In Perfins of the Ottoman empire and Turkey the perfins are shown in stamp issues of the Ottoman empire, the Turkish nationalist government and the Republic of Turkey.

Until the end of the nineteenth century Crete was a part of the Ottoman empire and perfins of foreign offices are known from this island. Some of these perfins can also be found in stamps of Crete. Therefore the author decided to include a chapter for all

Perfins of Crete from the periode before 1924.

Another important part of this handbook is formed by the *Catalogue of Levant perfins*. This section, starting with the *Introduction to the catalogue*, shows an alphabetical listing of all known Levant perfins. In this listing the author has integrated all perfins from the territory of the Ottoman empire, which have been illustrated separately in the other chapters of this handbook. Behind the different stamp issues the author has given an indication of the scarcity rate.

Finally, in *Perfin patterns and catalogue numbers* all perfin patterns together are shown in original size and in alphabetical order, with their corresponding catalogue numbers.

I must confess that Bob Schwerdt's article "My Favorite Foreign Perfin Page(s)" in the January/ February, 2009 issue of *The Perfins Bulletin* (63:7-8) started a search in our apartment. It culminated with the finding of my favorite perfin accumulation. Well perhaps it is a collection in that I do have them separated into envelopes by country. In any event, it turned up the two perfins shown below.







The cancel C(L) was included in Bob's list; however, I thought they might be of interest because of the denomination "para". The stamps are listed in Scott Standard Postage Stamp Catalog under Austria, Offices in the Turkish Empire as #21 and #22. These are the 20 para on 5 kr rose (left stamp) and 10 para on 3 kr green (right stamp). Both stamps are punched C(L) (or CL monogram). I place the

"C" first because I believe it to be the perfin of Le Crédit Lyonnais.

Crédit Lyonnais is a historic French bank. In the early 1990's it was the largest French bank, majority state-owned at that point. Crédit Lyonnais was the subject of poor management during that period





which almost led to its bankruptcy in 1993. It was acquired by another French bank (Crédit Agricole) in 2003 and is now known as LCL (Le Crédit Lyonnais)¹.
