Revenue Discoveries Still to be Made

Illustrated below are two U.S. perfins – LS/C and RSD/&Co. The first is listed in the *Catalog of United States Perfins* as L139 used by Lindstrom Smith & Company of Boston, Mass; the second is not listed. However, both are punched in US revenue stamps, so use of the catalog of postal perfins is improper; One must refer to Section A of the U.S. Revs – Perfins: A Handbook of Perforated or Punched Initials, Numbers and/or Designs in United States Revenues and Fiscal Documents. Neither is listed there (yet).



From the back of the stamp these look very much like postal perfins. However, as seen from the face both are Federal Documentary stamps. New discoveries are still relatively common in US revenues despite the huge effort made by Art Mongan in the production of the first version of the U.S. rev-perf catalog.



So, why don't you collect US revenue perfins?

The 2014 Schermack Control Perforation Census - Part II

First, let me say "Thank You!" to all of those collectors who contributed to this census. From large and small collections alike, all information was appreciated. I had the pleasure to make the acquaintance of many fellow collectors and am very grateful for that.

Information came to me in all forms. Many times I had questions. Together we worked through it and recorded the information to the best of our ability. Stamps that were reported without being watermarked were assigned as if they were the most common watermark already recorded for that particular pattern. If you were one of those that hadn't watermarked your stamps, perhaps you should. You might have a much rarer stamp than you realize.

In my original request for data, I promised that those sharing their information would get a copy of the data when it was complete. Because of my computer hard drive crash, I've lost all of your email addresses - I 'm sorry for that. So if you wish to receive a copy of the data in Excel spreadsheet form, please re-send your email address to me (cmccoy l@myfrontiermail .com) and I'll see that you get a file. If you don 't have email, you can drop me a note (10253 Collard Dr., Lakeview, MI 48850) and I'll send you a copy.

The Census

The format for tabulating the census was built a round the tables for control perforations presented by Steven Belasco in his 2009 book *Guide to United States Vending and Affixing Machine Perforations 1907-1927.* Data was supplemented with additional information from Steve Endicott, the U.S. Catalog Chairman for the *Catalog of United States Perfins*, published by The Perfins Club.

The census (Table I) was recorded by control pattern and by Scott number in Microsoft Excel spreadsheet format. Other data include *Perfins Catalog* number, number of control pattern stamps still on cover, and EDU and LDU by

control pattern and primary user when known. Items that are blank or show zero went unreported in this census.

Over 3 100 stamps with control perforations were reported. I'm sure that this is by far the largest recording of control perforations ever taken. Even so, there is no way possible that we have counted everything. I know of several collectors who, for whatever reason, did not share their data. Like any census, you never expect to count every last item out there. What you do hope to achieve is to get a large enough, broad enough sampling to get a good representation of the total population. I think we accomplished that with this census.

New Discoveries

The following are previously unknown (i. e., unrecorded) items that surfaced during the census:

- A Scott #314, previously unknown with a control mark, was found on a postcard. ¹
- A Scott #384 with Mailometer Type V perfs with a control perforation was reported.
- A Scott #346 was found with control pattern 34678, previously unknown on this Scott number.
- A Scott #344 was found with new control pattern 234569.
- A Scott #346 with the 12-hole open square control pattern was reported on piece postmarked 2/2611 9 10, Wall Street Sta., New York. The return address is missing, so the user is still unknown.
- An additional user, the Michigan Anti-Saloon League of Detroit, was found with control pattern 28.
- An additional user, Wilber Mercantile Agency of Chicago, was found with control pattern 48.
- An additional user, The Anglo-American Insurance Company of Chicago, was found with pattern 37.

Data by Control Pattern

Across all stamps, the control mark most often reported was pattern 13579 of the Julian Hawthorne Company, with 252 reported. Next highest was pattern 5689 of the John Wanamaker Company, with 181 copies reported, followed by pattern 45689 of the U.T. Hungerford Brass &






Fig 1. Cover strips derived from the Perfins Club website showing the use of a stamp perfinned with pattern D143 (above) and a second strip franked with a stamp perfinned pattern Z004 (below); perfin patterns D143 and Z004 are reproduced below the cover strips.

Copper Company (Figure 1), with 176 reported (see Table 2). Though generally found on stamps from the 1908 series, all three of these patterns had smaller quantities reported on stamps of the single line watermark 1910 series also, suggesting that a different valuation by Scott number might be in order.

Polish National Alliance Plus

Steve Endicott (#2284) and Paul Mistretta (LM#111)

Currently in 1998 *Catalog of US Perfins* the user for pattern D143 is identified as the *Polish Daily Weekly Zgoda*.

The user for pattern Z004 is shown as Związek Narodowy Polski with the Supplemental Information that "This was a newspaper". User for pattern Z004

Związek Narodowy Polski translates as the Polish National Alliance (PNA; an abbreviated form of the Polish National Alliance of the United States of North America.)

Cover strips for both these patterns are shown immediately below.

Before we go on, here are a couple of items which need to be noted based on the covers and the catalog information.

- The word "and" is missing between Daily and Weekly in the catalog user identification;
- Both covers have the same return address -- 1406-1408 W. Division St, Chicago, IL;
- Both covers are shown with business names in English;
- The user of pattern D143 is not shown in italics in the 1998 Catalog (the convention for publications); but, it is shown in italics in the eCatalog; and,
- The user for pattern Z004 is shown in the current Catalog as Związek Narodowy Polski with the Supplemental Information "This was a newspaper".

So, why this article; what do these items have in common, what else has been learned about the users of these patterns, and what adjustments need to be made to the information in the Catalog?

The most obvious linkage between these two patterns is given by the return addresses found on the cover strips. These are identical (1406-1408 W. Division Street, Chicago, Illinois) except for the name of the user. This is a significant hint that they are somehow related.

So now, let us turn to the internet for help with the information derived from the covers. What is to be found indicates that:

- Związek Narodowy Polski translates as the Polish National Alliance (the PNA; an abbreviated form of the Polish National Alliance of the United States of North America);
- The PNA was initially formed simultaneously in Philadelphia and Chicago by Polish exiles devoted to the twin goals of Polish independence and the assimilation of Poles into American society.
- At the present time the PNA is self-described as a fraternal insurance benefit society that is not just for Americans of Polish heritage. It is open to everyone.
- In 1881, the PNA began publishing its own Polish language newspaper, Zgoda [Harmony] to promote its objectives to the larger community;
- The *Polish Daily Zgoda* and the *Weekly Zgoda* were the official newspapers of the Polish National Alliance. These newspapers superseded the *Zgoda*. Publication began on January 9, 1908;
- Publication is five times a week four smaller dailies (published Monday – Thursday) and a larger combined weekend edition (published on Friday);
- The Polish name for the newspaper is *Dziennik Związkowy*, a clear match for the pattern D143 which is "DZ";
- Alternate names for the newspaper include *Zgoda* and the *Polish Daily Zgoda*; and,
- The newspaper continues publication at the present time (as *The Polish Daily News*) and is

the longest continuously published Polish language newspaper in the world.

Changes to the Catalog resulting from the above include:

• D143

- o Identify the primary user as *Dziennik* związkowy, Chicago, Illinois;
- Include in Supplemental Information alternate names: Zgoda, the Polish Daily Zgoda and the Weekly Zgoda and the Polish Daily News;
- o Include cancel date (9/15/16) in the catalog;
- Note: the italics in the user ID will identify this as a publication, but perhaps should also add in the Supplemental stuff – "The official newspaper of the Polish National Alliance, user of perfin pattern Z004" or similar.

• Z004

- o Identity of primary user Związek Narodowy Polski, Chicago, Illinois
- Include in Supplemental Information the Polish National Alliance (an abbreviated form of the Polish National Alliance of the United States of North America)
- The PNA is a fraternal organization and not a newspaper as reported in previous editions of this catalog.

Jersey International Response Coupons –Additional Information

Jeff Turnbull (The Perfins Society [of Great Britain]) writes:

I have recently seen an item in your Bulletin by Stephen Tauber #2949; the item refers to the international reply coupons issued by Jersey British Channel Islands, and perfin JE.

I also have a number of these coupons (see attached scans) and can add to the item.



In 1974 the Universal Postal Union passed a regulation empowering member authorities to give these reply coupons a distinctive perforation to identify their country of origin (Jersey being "JE").

You will also see from the scans that some of my items bear the circular dated cancel of the Philatelic Service of the Channel Islands (1976-1981), and various monetary values in black or red ink.

I am in agreement with what Stephen says about these being purely philatelic items, but interesting none-the-less. Who knows, we may one day find a used one!

And a note from **Jack Brandt** (LM14) adds the following information

Probably 95% of the reply coupons are sold by the Philatelic Bureau, and whether they are cancelled or not depends on the clerk filling the order. I enclose 3 photocopies from my collection [Ed. Note: In the interest of space, only 1 of these items is reproduced; the other two essentially duplicate similar pieces shown above or in the original Tauber article.] The 13p was bought a long time ago directly from the Jersey Philatelic Bureau; no cancels are present. The 20p and the 25p were bought from a dealer (along with a couple of others). The cancel at left (the sales cancel) is that of the Philatelic Service. These items were probably purchased by mail.

The 20p item (shown below) has two cancels. [Ed. Note: the left cancel identifies the dispensing office while that on the right identifies the redeeming office; normally these are from offices in different countries.] The cancels on the 20p coupon are the same (same place, same date – see below). It was unlikely that it was used to redeem a stamp. The 25p coupon has a single cancel as would be expected of a purchased but unredeemed coupon...



The 2016 Catalogue of Worldwide Reply Coupons, Vol. 1 – UPU, Coupons by Yao and Yao prices 12 Jersey coupons with the "JE" perfin. They also list 5 others which are unpriced and which may not actually exist. Values reported for these coupons are: 13p, 20p on 13p, 20p, 20p, 25p, 30p, 35p on 30p, 35p, 55p, and 60p. Some exist with 2 different backs.


Notes on the Numbering of Patterns

Steve Endicott (#2284)


Why do some perfin IDs have numeric suffixes and others have alphabetic suffixes?

A decimal suffix (numeric) indicates the insertion of a pattern between two other patterns. The new pattern differs from the one next to it if the patterns are different in significant design elements, number of pins, OR the overall dimensions of the other pattern.

For example, consider patterns A55and A55.5 on page A-7 of the *1998 US Perfins Catalog*. The letter C in pattern A055.5 has one less punched hole.




A numeric suffix separated from the pattern number by a hyphen ("-") indicates a pattern in a family of patterns from different branch offices of the same company. For example A221-02 and A221-03.




Alpha suffixes indicate patterns having the same basic design, same number of pins, AND the same overall dimensions of pattern which will also have the same base catalog number. The pattern differs from the other listed patterns in some other aspect such as the shape of a letter.

For example, consider patterns A046, A046A and A046B, also on page A-7 of the Catalog. The letters of the design, number of pins and overall dimensions

are the same, but the shapes of the letters A and B are different.



Combinations of numeric and alphabetic suffixes also are found in the catalog referencing both variations in the basic patterns (generally a distant control hole) and minor variations in the location of individual pins. A sample of this from the N113 family of patterns is presented below



Finally, sometimes a perfin ID number is absent from the current catalog. For example, pattern A14 is followed by pattern A16. Pattern A15 was deleted as a variety of A16 during the development of the 1979 edition of the Catalog.

Taxonomy of perfin identification numbers can get complicated; a detailed explanation will be included in the appendix of the next edition of *the United States Perfins Catalog*.

An Embarrassing Mistake

Ken Masters (LM #3589)

Whenever I find a cover with a New York Life Insurance Company corner card franked with a stamp with the familiar NLY perfin, I immediately assume this is one of the many in the N113-XX series. Therefore, to identify that particular perfin, I start looking for a control hole(s) and turn to the pages near the end of the Letter N section of the Catalog of United States Perfins (US Perfins Catalog).




Fig. 1. New York Life Insurance Company, New York, NY, cover franked with 6 cent air mail stamp (Scott #C33) that is perfinned with pattern N113.5B not N113-00.

This situation occurred a few months ago when I

was going through a shoebox of perfin covers that waited to be identified and mounted. Among this accumulation was the airmail cover shown in Fig. 1 below. Seeing no control holes in the perfin, I immediately identified it as pattern N113-00. The Catalog shows the user city for this pattern is New York, NY, which matches the corner card on the cover. The postmark is New York, NY, which further verified my identification. Also, the previous owner had penciled "N113.0 - E" on the bottom of the cover. Nothing great and wonderful yet.

However, when I compared the March 5, 1953, postmark with the current version of the postmark database, it appeared this is a new Latest Known Use (LKU) for N113-00. As the 6¢ airmail stamp (Scott #C33) was issued March 26, 1947, the cover also updates N113-00 "dates of usage" to 1908-1947. The next step was to email this information along with a scan of the cover to Catalog Chairman, Steve Endicott, suggesting these updates should be made.

Soon, he sent an email message back to me asking that I carefully check the stamp for dimples or other hints of a control hole(s). He did not think the perfin

is pattern N113-00 for two reasons. First, the crossbar of the letter N is completely different than N113-00. Second, the postmark and date of issue of the stamp are decades later than previously known. He further pointed out that there are two types of crossbars for the N113-XX series - the first being angled with the ends of the crossbar close to the two vertical legs of the letter N. In the second type, the crossbar is more upright and the ends visually separated from the two legs. If, in fact, there is no evidence of a control hole(s) in the perfin on the cover, the crossbar suggests that this might be a new pattern!

Excited with this possibility, I immediately started carefully examining the perfin on the cover for evidence of a control hole(s). It was then that I noticed the bottom leg of the letter L only contains 3 holes, not the 4 holes required for pattern N113-00 (or any other of the N113-XX series). Under magnification, I could see no evidence of a missing hole at the end of the bottom leg of the letter L and no dimples elsewhere in the stamp.




Fig. 2. Catalog images: Patterns N113-XX, N113.5A, and N113.5B Note there are 3 holes in the bottom leg of Patterns N113.5A and N113.5B and 4 holes in the bottom leg of Pattern N113-XX series.

In the back of my mind, I vaguely remembered a couple of New York Life Insurance Company perfins shown in the Catalog that are close to, but not part of the N113-XX series. Off to the Catalog where I saw patterns N113.5A and N113.5B. Both of these patterns have only 3 holes in the bottom leg of the letter L, but I had previously completely ignored them (see Figure 2 below).

After a closer examination of the perfin on the cover, I determined it is pattern N113.5B. The letter N is wider than pattern N113.5A and the holes in the vertical leg of the letter L and the crossbar of the letter N are evenly spaced. In addition, the issue date of the 6 cent airmail stamp fits into the "dates of

usage" shown in the Catalog for N113.5B. Finally, an electronic comparison of the stamp with the Catalog image of N113.5B provided a definite identification.

My task now was to report this information to the Catalog Chairman and confess my embarrassment of my carelessness in my initial identification of the perfin. He replied back that he was embarrassed also and that he should have caught the difference in the letter L

The good news is that the postmark database did not have a reported postmark for N113.5B. So, the cover at least contributes there. Actually, after looking at the other covers in my collection, I found another one with a N113.5B that I had also misidentified. The postmark date on this second one is April 29, 1937. Thus, until further updates are reported, the Earliest Known Use (EKU) of N113.5B is 04/29/1937, and the LKU is 03/05/1953. However, with an E rated perfin, there must be an earlier or later postmarked cover out there. At your convenience, please check your collection and report any such dates to the Catalog Chairman.

Finally, prior to this time, an image of a cover with N113.5B was not among those shown on the Club's website, <u>www.perfins.org</u>. A scan of the cover was forwarded to Robert Littrell and it is now among the 1,700 other covers currently displayed there.

Every story has a moral. This one is a confirmation of the old saw: "Look before you leap." Or maybe it is: "Check and double check or you may put your foot in it!"

Cover Illustrations to be in The Catalog of US Perfins

Steve Endicott (LM-2284)

Illustrations of perfins on cover will be included in the electronic version of the next edition of the *US Perfins Catalog*. This is being accomplished by the fine work of Robert Littrell, the Perfins Cover Manager, and the input of scanned covers by members, notably many submissions by Dan Baugher,

Larry Cohen, Jerry Hejduk, Jon Johnson, Ken Masters, Rudy Roy and John Welsch. Over 1600 covers have been recorded. The illustrations are available for viewing at the Perfins Club website, http://www.perfins.org/, by selecting the tabs "Perfins Info" and then "US Perfins Covers."

While recording url links in the US Catalog to these covers and comparing the existence of each cover to other catalog information, I have noticed some interesting data that I want to share.

First, for perfins for which the user has been identified and verified: Although covers have been located, submitted to Robert Littrell and recorded, there are 2,711 perfins for which we currently do not have covers. This is mostly impossible! Covers with identification are out there in our collections; some of these patterns are common. Here is opportunity for all perfins collectors to check covers in their collections against the covers at the Club

website to see where you have additional information for us. Please submit your findings to Robert (his contact information is on the inside second page of this issue).

Readers might notice a strange phenomenon in the second table and ask "How can we know the user and have a cover, but not be able to verify the user?" (column 1) and "How can we have a cover, but not know the user?" (column 3). These few cases occur where either there is no return address on the envelope or the perfin is on a postcard without any identification of the corporate user.

From April 9, 1908 through May 5, 1908, the post office required that pin holes be no larger in diameter than 1/64th of an inch. This regulation was quickly changed to 1/32nd of an inch. I would like to include an example, on cover, in the Introduction to the next edition of the U.S. Perfins Catalog. Examples of perfins with the thin pin configuration are D041.7, K047, S258 and T109.5
- Perforators Do you own a single die perforator? If so, could you take a picture of it (against a white

- background). I would like to include photographs of various perforators in the Introduction to the next edition of the US Perfins Catalog.
- A 10-die perforator sold on eBay on March 19, 2017. It is pattern G129 used by the Gulf, Mobile & Ohio Railroad Company in stamps issued from 1938 through 1968.
