This listing includes the Precancel Stamp Society's town & Type pattern identifier (Fig. 1), where known, for the precancel device which was overprinted on each of the designated perfins. These types are reproduced for those collectors of perfins who are unfamiliar with the precancel types reported.

Fig. 2, Columbus Ohio precancel types reported found on prepers from that city. Types 43 and 61 were printed by the Bureau of Printing and Engraving in Washington, D. C.; types 204, 212 and 232 were electroplates provided by the Bureau to the post office for use by printers in the local area of the post office to precancel stamps under contract with the Post Office; type 454 was produced by a rubber handstamp provided by the Bureau and used at the Post Office; and, Type L-3 was a locally produced

device (generally a handstamp) which was contracted locally and used at the Post Office. It goes without saying, but I'll say it anyway, all of the precancels related to Columbus, Ohio, bear some variation of the city name with or without coma, and with or without Ohio spelled out, consistent with the above illustrations.

# New Checklist of US Perfins

# User of U.S Pattern S160 Identified

Below you will see a scan of a cover that I recently acquired with perfin S160, a B-rated perfin. It shows

the user, unidentified until now, to be the South Jersey Realty Company of Philadelphia, PA.

In 1905, three Risley brothers bought the entire town of Stone Harbor, NJ at a Sheriff's Sale. Shortly thereafter Horace S. Risley founded the South Jersey Realty Company to profit from the island's development. Roads were laid out, water lines installed and sidewalks were built.



In 1911, a road was completed from the mainland to Stone Harbor.

Governor Woodrow Wilson visited the opening ceremony and the island began to grow into a popular destination for summer vacationers. In 1914, the borough of Stone Harbor was incorporated as a borough in Cape May County. It is located on an Atlantic coastal isthmus in this southernmost tip of New Jersey.

Although books have been written about Stone Harbor, the South Jersey Realty Company remains a footnote. Today, Stone Harbor is known as one of the more elite resorts along the Jersey Shore. Perhaps other members have information regarding the South Jersey Realty Company.

Steve Endicott, U.S. Catalog Chair, has confirmed for me that this user identification will be included in A&C#1 to the new U.S. Perfins Catalog. Also, the postmark on the cover provides the OKU for this B-rated perfin. Steve and Paul Mistretta both researched the strange town listing of Bonne Terre, MO for this perfin. The town identification was introduced in the 1979 Catalog. It appears to be a typographical error, being a duplication of the town listed for the perfin just above it. This town will be removed in A&C#1.

# Pattern S195-62 -- Standard Oil Company


### **Background Information**

At the Boxborough convention I had the opportunity to meet our US catalog chairman, Steve Endicott, and present him with the findings detailed in this report. After a lengthy discussion among some of the collectors there, it was agreed upon that this article would be written and submitted to the Perfins Bulletin. Mr. Endicott, and others, would include their comments concerning how to handle any changes to the catalog entry for this pattern and publish the results in the Bulletin for further member feedback. While this discovery is new and somewhat surprising we have to travel back forty years to start the story.

About 1976 I noticed an ad in a local paper from Upper Sandusky describing a stamp collection for sale. A call was made. After a short drive, an elderly gentleman presented a box filled with stamps, in hundreds of bundles that had been steamed off their family business mail--mainly during the 1920's. Each bundle, tied with string, contained 100 stamps sorted by design. The total must have been around 30,000 or so stamps. After purchasing the collection, weeks were spent reviewing the lot and putting some in stock books. Knowing nothing about perfins at that time no attention was paid to them.

Fast forward 20 years to around 1999. The purchase of the US Perfins catalog started me on

the road to this report. While sorting perfins from my piles of stamps, one of pattern **S195-62** popped up. Finding it to be a "B" rated pattern I searched for more. When the search was completed, there was found to be a



total of 858 stamps with this perfin. They were all from that box bought in 1976. I theorize the family the collection was purchased from may have run the local Standard Oil service station in Upper Sandusky, and these stamps were all from their business mail from the "home" office in Toledo.

Now we fast forward to 2015 and provide the details of this find that was introduced in Boxborough.

### The Stamps

The stamps will be described in chronological order, and important details will be provided with selected illustrations from the 858-piece collection.

The earliest stamps found are from the 1917-19 Washington Franklin issues of flat plate printings perforated 11 and un-watermarked. These are listed in the table below and total 217 stamps.

The earliest postmarks visible are pictured below;

a two digit 21 and a partial 1921 both on Scott #510 stamps.



The largest multiple was a block of six Scott #510 stamps below.





The only other multiple larger than a pair was a vertical strip of five Scott #504 stamps.

The next issue present was Scott #528B, the 2¢ carmine Washington, Type VII, from the 1918-20 offset printings. Un-watermarked and perforated 11, only four of these stamps were found.

Next came the 1921, perforated 10, 1¢ green Washington from the rotary press issue. This is Scott #543 and there are 30 of them in the find.

The next surprise was the use of this pattern on commemorative stamps from the 1920 Pilgrim Tercentenary issue. There are 12 of Scott #548, the 1¢ green "Mayflower" and only 2 of the 5¢ blue, Scott #550, "Signing of the Compact". (Pictured below)



Now we are up to the 1922-25, perforated 11, flat plate issues.

Once again the table below enumerates this large group.


With 247 stamps in this group it represents the greatest concentration of stamps and thus might be considered the peak usage period. One of the most interesting items from this group is the broken pair of  $4\phi$  Martha Washington stamps where the circular date stamp cancellation

appears to link the two stamps together. With both of them straight edge, bottom row stamps it is highly likely they were a pair on a cover. The postmark is clearly from Toledo, Ohio, dated January 21, 1924.



The 10¢ yellow Monroe stamp provides some good examples of box and oval cancellations also present on many of the stamps. All of the legible cancellations in the collection are from

Toledo, Ohio. This draws into question the current catalog listing of Columbus as the location of the user.

Next we have the perforated  $11 \times 10 \frac{1}{2}$  issues of 1926-34. We find five denominations in this

area as shown in the table below containing 159 stamps.

Lastly we end with three stamps from the 1938 Prexy series - two  $1\frac{1}{2}\phi$  Martha Washingtons and one  $3\phi$  Jefferson. At this point there appears to have been some damage to the perforator with partial patterns visible. With only three examples and no dated postmarks present, we cannot document an LKU clearly at this time.



### Summary

Prior to the Prexy issues, all of the patterns in these stamps are complete. The vast majority are nicely centered and punched from the front in an upright position. With a total of 858 stamps and the Toledo, Ohio postmark evidence it is now in the hands of the catalog committee to adjust the entry for pattern S195-62 as they deem necessary. # The 2014 Schermack Control Perforation Census Part V (Part 2; see May/June Bulletin for Part 1 & disclaimer)

## Kabo Corset Co. and Wilber Mercantile Agency


Figure 5. Covers with control perfins from Kabo Corset Co. (top) and Mercantile Agency (bottom). Note that both covers were mailed from Chicago's Carpenter Street Station.

Control pattern 48 also proved to be quite interesting. Used by the Kabo Corset Company (Figure 5), that pattern's earliest reported use was dated 9/23/1910. Based on reported covers, they were one of the last companies to start using a Mailometer Mailing Machine with control marks. Covers were reported dated steadily from late 1910 through February 1912. But then, for some reason, no more covers are reported for an entire year! Finally, in late February and early March of 1913, three covers were reported. But then they stop once again, with no more covers reported during the next eight months! The drought was broken on 11/8/1913,when the newly reported user, Wilber Mercantile Agency (Figure 5), showed up

using Kabo Corset 's control pattern 48 on an envelope. At first glance, with a name like Wilber Mercantile, one might suspect them to be either a supplier or customer of the Kabo Corset Company. The envelope was addressed, in very fine penmanship, to Allen & Miller, Morganfield, Ky. Then, one month after the Wilber cover, Kabo's mailing machine was running again, processing Kabo Corset envelopes. The LDU of control pattern 48 was 2/10/1914. The long periods of down time may have taken a toll on the equipment. As we outlined in the broken pin discussion (Part IV, May *Specialist*), after that date, pins started to break at a rapid rate.

As it turns out, Wilber Mercantile Agency was actually a group of lawyers that specialized in debt collection. Perhaps a financial situation at Kabo Corset was the cause of the two prolonged mail stoppages. More research is needed regarding this possibility. Also note that both the Kabo and the Wilber covers were posted at the Chicago Carpenter Street Station. This suggests that the two companies were located near each other. I suspect that Wilber was actually using Kabo's mailing department.

## Edison Cover and Babson Brothers

The size of the mailer and/or the weight of the contents in the cover shown in Figure 6 required the use of a  $3\phi$  postage stamp and the Chicago oval handstamp cancellation on this cover mailed at the printed matter rate ( $1\phi$  per 2 oz.,  $3\phi$  for more than 4 oz., up to 6 oz.). This mailer does appear to have been folded in the middle. That may have been done to facilitate the processing of the empty envelope through the Babson Brothers' Mailometer Mailing Machine, with the contents of the envelope to be stuffed later.

"loss leaders," with Babson making their profits later on the sale of recordings. At the same time as this was going on, the phonograph industry was changing - from playing cylinders to playing discs. It took Babson several years to dispose of the all the Edison Phonographs they had purchased (see Figure 7). They even had to open a storefront in Chicago finally to move them all.<sup>1</sup>

Babson Brothers was a large mail order house in Chicago. They bought directly from manufacturers in volume and sold items through their catalog. Their customers received discounts because Babson was able to purchase in volume. Sales promotions were often announced through their mailings.

One special deal was the purchase of a trainload of Edison Phonographs, which were usually used as

## Fidelity-Phenix Insurance Co.

Control pattern 9 is known on many covers originating with the Fidelity Phenix Insurance Co.

(Figure 8). However, control pattern 9 is known on one cover postmarked from the State of California with the printed address of The World Manufacturing Co. of Cincinnati (Figure 8). I have



no information on any relationship that may have existed between Fidelity-Phenix and World Manufacturing. Perhaps the stamp was found uncancelled on a cover from Fidelity-Phenix, peeled off and reused. This is a logical possibility, since the stamp placement (sideways) indicates that it was not applied by a Schermack Mailing Machine, but most likely was applied by hand, supporting that it was most likely a reuse.

## Rare Perfins On Cover

Two particularly scarce on-cover patterns were reported, pattern 12456 of the W.M. Crane Company (two examples reported; Figure 9) and pattern 23456 of the Dealers Protective Association (one example reported; Figure 10.)

## User of Mexico Perfin Pattern A6, "H.S." Identified John Welsch (#3832)

I recently purchased a Mexican perfin cover in Bob Szymanski's (#LM145) Perfin Auction #73, March 2017. It was franked with pattern **A6**, "H.S.", unknown user in the Mexico chapter of the American Section Schwerdt's World Perfins Catalogue,.

The cover identifies the user of this pattern as Heymann Sucesores, Mazatlan, Sinaloa State, Mexico. They were one of the principal commercial enterprises in Mazatlan in the 1890s.

The company, run by merchant importers of German descent, was a Merceria, sellers of notions and hardware, books, stationery, china, glassware, fancy goods, groceries and provisions, agricultural implements, iron, and ironware.

The oval handstamp of the Heymann Sucesores, Mazatlan appears on the reverse side of the cover.

Two Mexico 1896-97 postal issues, Scott #258 (2 centavo) and #259 (3 centavo) pay the 5 centavo international letter rate to the United States.



Originating in Mazatlan, on the west coast of Mexico, the cancel is dated AGO.18.97.10AM, (18th of August, 1897, 10AM)

The addressee is Export Printing & Publishing Co., New York, 193 West Street, U.S.A. Backstamps indicate the cover went to San Francisco, Cal. Aug. 26, 1987, and arrived in New York Aug. 31, 1897 confirmed by an interesting circular date stamp, P.O.N.Y. (Post Office New York). A third circular cancel, V, 9-1-97, appears to be a receiving date stamp. If anyone can identify this cancel please let me know.

Mexican postal perfin pattern "H.S." is the same as the Mexico Revenue pattern B5, "H.S." also listed as an unknown user. The Revenue "H.S." is found on Renta Interior tax stamps. Merchants had to affix stamps on all commercial documents to represent receipt in payment of the appropriate taxes. Every purchase amounting to more than \$20 at any shop,

store, or factory, or from any individual, had to be accompanied by a bill describing the article and naming the price. That bill had to bear a stamp, amounting to one-half percent of the value of the purchase. Different design Tax stamps were issued every year. As with postal issues, the merchant could avoid stamp theft by perforating their initials, "H.S.". in this case, on both his postage stamps and tax stamps.

Two other users of Mexico perfin patterns were located in Mazatlan, both also merchant importers German descent: Bartning y Sucesores, user of pattern A1 in postage and B3 in Revenues 1883-98, and Melchers, user of pattern A9 in postage and B6 in revenues, 1884-92.

This cover represents an important addition to Mexican postal history and the Mexico Perfins Catalogue. There are only 14 identified users of Mexico postal perfin patterns. Eight other Perforated Initials and several Design patterns in Mexican stamps are still unidentified.

## Do you collect Irish Perfins?



'The Gault Catalogue of Irish Perfins' is a 162 page, all colour, loose leaf publication covering the 125 year period 1870-1995. The 52 page introduction delves into the earliest use of perfins in Ireland, Irish Braham Dies, POKO's, Sloper Wartime Provisionals, Railways, Irish 1922 Overprints, early Eire commemoratives, Airmails, Postal Stationery, Trade Mark Perfins, and a lot, lot more. This is followed by details of all 684 known dies, listing all known stamps (5,201 DDF), postmarks, identities, etc.; in essence, the culmination of twenty-five years of research.

Prices are £25 (plus postage) for Perfin Society Members, and £30 (plus postage) for non-Members. [Ed. Note: on May 26, 2018, the exchange rate was US\$1.32 per 1£ British.; prices in US\$ would be  $\sim$ \$33/\$40 + postage respectively.]

# Canal Zone PSN Perfins Sold

In last month's Bulletin an announcement from Mike Drabik, Secretary of the Canal Zone Study Group was published noting the start of a survey of the PSN perfin in Canal Zone stamps. This census hopes to establish the availability of the PSN perfin in several issues of Canal Zone stamps. The May/June Bulletin was e-mailed to Ken Masters for publication on the 15<sup>th</sup> of April. On that same day an auction closed which may give cause for serious consideration of that pattern as a rarity in the world of perfins. It also gives impetus to collectors to share their information to avoid falsely inflated prices for this pattern.

The lot in question was described as: "Stamps -Canal Zone. A selection of 7 :P.S.N." perfins on different stamps. FU." Condition: "All in good condition and fine used".

Beginning with a Start Bid of 9.99 £ this lot received 27 bids. The selling price achieved was GB£191 or approximately \$272! The stamps, Sc#s 114 (\$0.65), 138 (\$0.25), 139 (\$0.25), 141 (\$1.00), 143 (\$0.30), C9 (\$0.35), and C11 (\$0.25) have a total Scotts 2015 catalog value of only \$2.60.



Does anyone out there have an explanation for these stamps selling at 105 x catalog value (that is 10,500% of catalog value!)? There is clearly nothing particularly special about the base stamps. Are these perfins truly that rare or is something else going on here?

Ed. Note: With his review of the "proof copy for this article Rudy included the following information: "here is a comparison of 4 lots in the CZSG's November 17 [2017] auction with prices realized: Scott 105, 108, and 117 est. at \$75 sold for \$56

Scott 115 est. at \$50 sold for \$150 (this was a tie bid so probably price is skewed) Scott 116 est. at \$75 sold for \$85 Scott 141 est. at \$15 sold for \$19

"I would offer that with so many bids (22 I think?) there may have been a couple of bidders who got caught up in the process and jacked up the price. ...the perfins Catalog rates these as A though they probably ought to be C."

All were the PSN pattern.
